I. Program Description

The goal of the U.S. Fish and Wildlife Service Regional Joint Venture (JV) Office is to assist partners in implementing effective science-based bird conservation projects in the Upper Mississippi / Great Lakes Joint Venture (UMGLJV) region. The JV has an Implementation Plan and conservation strategies identifying bird habitat, monitoring, and research needs with an emphasis on JV focal species. These plans and associated research and monitoring needs can be found at www.uppermississgreatlakesjv.org.

Following are themes prominent in the UMGLJV Implementation Plan: 1) Test model assumptions, determine factors most limiting population growth, and build / refine models predicting how populations of priority breeding species (JV focal species) respond to habitat change; 2) Improve understanding of migration and wintering habitat selection, survival, migration chronology, and human influences on migrating and wintering bird populations to better predict habitat needs and target conservation areas; 3) Assess bird densities and vital rates relative to estimates used in JV models predicting carrying capacity for breeding birds in quality habitats; and 4) evaluate habitat carrying capacity for priority migrating and wintering bird populations (JV focal species and guilds).

Department of Interior's Secretarial Priorities

The Secretary of the Department of Interior (DOI) developed a list of ten priorities to support both the public purpose and Service and DOI missions. Migratory Bird JVs support five of the ten DOI Priorities. During the development of your proposals, consider how the Service's Joint Venture funding will be used to support the Secretarial priorities below:

1. Creating a conservation stewardship legacy second only to Teddy Roosevelt: The North American Waterfowl Management Plan (NAWMP or Plan) is an international accord signed by the U.S. and Canada in 1986 and by Mexico in 1994. For the past 32 years, the Plan has helped to sustain abundant waterfowl populations across North America by conserving priority landscapes. Through innovative partnerships combining sound-science, boots-on-the-ground conservation delivery, and public and policy engagement, the Plan has world-wide recognition as a model to effectively achieve continental-scale wildlife conservation. The habitat goals of the Plan are primarily implemented by JVs — a network of regional, self-directed partnerships involving Federal, State, and local governments; corporations; individuals; and non-government conservation groups. By catalyzing partnerships through a voluntary, non-regulatory approach, JVs leverage a diversity of conservation expertise, create collaborations at a variety of scales, and make conservation entities stronger through a focus on improving effectiveness and efficiency in others. This partnership approach is a “win-win” endeavor that addresses the needs of birds and other wildlife, while also providing benefits to working lands, agriculture, and rural communities.

2. Utilizing our natural resources: JV partnerships utilize voluntary, incentive-based conservation programs to implement sustainable conservation practices that support birds and other wildlife, while also providing benefits to agriculture, forestry, and other working lands through outcomes that include improved forage quality, reduced risk of wildfire and invasive species, and improved forest health and timber value.

3. Restoring trust in local communities: JVs are regional, self-directed partnerships involving Federal, State, and local governments; corporations; individuals; and non-government conservation groups. In conjunction with partners and local habitat projects, JVs address local, regional, and continental goals for sustaining waterfowl and other migratory birds working locally with communities to conserve habitat for the benefit of birds, other wildlife, and people.

4. Generating additional revenues to support DOI & National Interests: FWS does not fund the entire scope of JV operations, and JV partners are expected to contribute funding towards one or more of these categories. JV partners have historically provided more than \$30 for every federally appropriated dollar to support the JV partnerships.

5. Striking a regulatory balance: JV partnerships address the priorities of “Striking a regulatory balance” by confronting conservation needs and concerns voluntarily and locally, potentially negating the need for more burdensome administrative rules and regulations.

II. Federal Award Information

The JV will issue approximately five grants annually under this NOFO ranging in amounts from \$1,000 to \$50,000 (multi-year grants may be issued contingent on funding, with a multi-year funding maximum of \$100,000). The JV has identified priority evaluation needs to fill information gaps and test assumptions used in plan development. Proposals for monitoring and applied research that improve JV conservation decision tools at larger scales (e.g., Bird Conservation Region) will be given higher grant priority. In addition, projects to address conservation priorities in State Wildlife Action Plans

(<https://www.fishwildlife.org/afwa-informs/state-wildlife-action-plans>), and for JV focal species, should be highlighted. Proposals related to coordination, outreach, planning, and bird habitat restoration / enhancement contributing toward goals identified in the JV plans will also be considered, if adequate funds are available. All submissions should explain how the outcome of proposed projects is regional in scope.

III. Eligibility Information

A. Eligible Applicants

Federal, State and local government agencies, Federally recognized Indian Tribal governments, private or public nonprofit institutions/organizations having a 501(c)(3) status with the Internal Revenue Service, profit organizations, state and public controlled institutions of higher education, private institutions of higher education, interstate and intrastate entities, and individuals or families who are also private landowners are eligible to apply.

U.S. non-profit, non-governmental organizations with 501(c)(3) Internal Revenue Status (IRS) must provide a copy of their Section 501(c)(3) status determination letter received from the IRS.

B. Cost Sharing or Matching

All proposals should have a minimum **1:1 match** of non-Federal dollars to Joint Venture request, and the partners providing secured match must be identified. Applicants may attribute some or all of their allowable indirect costs as voluntary committed cost-share/match.

C. Other Eligibility Criteria

Unique Entity Identifier and System for Award Management (SAM.gov) Registration: This requirement does not apply to individuals applying for funds as a private citizen (i.e., unrelated to any business or nonprofit organization you may own or operate in your name) or any entity with an exception approved by the Service under [2 CFR 25.110\(d\)](#). All other applicants are required to obtain a Data Universal Numbering System (DUNS) number from Dun & Bradstreet and then register in SAM.gov prior to submitting a Federal award application. Federal award recipients must continue to maintain an active SAM.gov registration with current information through the life of their Federal award(s). The Service may not make a Federal award to an applicant that has not completed the SAM.gov registration. B. Application Form and Content Requirements

To be considered for funding under this funding opportunity, an application must contain:

1. SF-424, Application for Federal Assistance

Applicants must submit the appropriate Standard Form (SF)-424, Application for Federal Assistance. Individuals applying as a private citizen (i.e., unrelated to any business or nonprofit organization you may own or operate in your name), must complete the [SF-424, Application for Federal Assistance-Individual](#) form. All other applicants must complete the standard [SF-424, Application for Federal Assistance](#). All of the required application forms are available on the “Packages” tab of this Funding Opportunity on Grants.gov. The SF-424, Application for Federal Assistance must be complete, and signed and dated. Please note: Enter only the amount requested from this Federal program in the “Federal” funding box on the SF-424 Application form. Failure to provide complete information may cause delays, postponement, or rejection of the application.

V. Submission Requirements

A. Unique Entity Identifier and System for Award Management (SAM.gov) Registration

These requirements do not apply to any individual applying for funds as a private citizen or any entity with an exception approved by the Federal awarding agency under [2 CFR 25.110\(d\)](#). All other applicants are required to obtain a Data Universal Numbering System (DUNS) number from Dun & Bradstreet and provide that number in the application; complete SAM.gov registration before submitting an application; and continue to maintain an active SAM.gov registration with current information at all times when the entity has an active Federal award or application under consideration. **There is NO COST to register with Dun & Bradstreet or SAM.gov.** There are third-party vendors who will charge a fee in exchange for registering entities with Dun & Bradstreet and SAM.gov; **please be aware you can register and request help for free.**

2. Register with SAM

Register on the [SAM.gov website](#). The official website address is <http://www.sam.gov>. The "Help" tab on the website contains User Guides and other information to assist you with registration. The [Grants.gov Register with SAM" webpage](#) also provides detailed instructions. You can also contact the supporting [Federal Service Desk](#) for help registering in SAM. Once registered in SAM, entities must renew and revalidate their SAM registration at least once every 12 months from the date previously registered. C. Intergovernmental Review

D. Funding Restrictions

Funding will be restricted to proposals focusing on monitoring and applied research that improve JV conservation decision tools at larger scales (e.g., Bird Conservation Region). Proposals related to coordination, outreach, planning, and bird habitat restoration / enhancement contributing toward goals identified in the JV plans will also be considered, if adequate funds are available.

The reimbursement of pre-Federal award costs will be allowed. If approved the notice of award letter will state the approval of pre-Federal award costs. If applying for pre-Federal award costs, be sure to make the actions, timeline, and amount of pre-award costs clear and justifiable in the proposal and budget.

E. Submission Instructions

Completed proposals should be submitted electronically to Grants.gov (does not apply to proposals from FWS staff) or emailed to anna_sidie-slettedahl@fws.gov no later than April 30, 2019. See below for details.

This program encourages applicants to submit their applications online through Grants.gov. **Follow these steps to apply through Grants.gov:**

1. Register with Grants.gov

Applicants must first [register an account with Grants.gov](#) and complete all steps of the registration process before they can apply through Grants.gov. Grants.gov registration requires the entity to create an account, create an account profile, and establish authorized profile roles, including the applicant's authorized representative. Registration can take three to five business days or longer, if you do not complete the required steps in a timely manner.

2. Grants.gov Workspace Application

Grants.gov applicants apply online using Workspace. Workspace is a shared, online environment where members of a grant team may simultaneously access and edit different webforms within an application. For each funding opportunity announcement, you can create individual instances of a workspace. To apply, the applicant will [create, complete, and submit a Workspace application package for this Funding Opportunity directly on Grants.gov](#). Grants.gov recommends submitting your application package at least 24-48 hours prior to the close date to allow time to correct any potential technical issues that may disrupt the application submission. When attaching files to the Grants.gov application, please do not assign file names longer than 20 characters, including spaces. File names longer than 20 characters will prevent your application received by Grants.gov from automatically downloading into the Service's financial assistance management system. Applicants using slow internet, such as dial-up connections, should be aware that the transmission of the application to Grants.gov takes time. Grants.gov sends either an error message or a "successfully received" message by email to the applicant's authorized representative once the transmission is complete. Please do not end the transmission process before receiving that message.

3. Proof of Timely Submission

Grants.gov automatically generates an electronic date and time stamp in the system upon application receipt. Grants.gov sends an acknowledgement of receipt with the date and time stamp and a unique Grants.gov application tracking number to the authorized representative by email. This email from Grants.gov serves as your proof of timely submission.

To submit an application by e-mail:

1. Format all of your documents to print on Letter size (8 ½" x 11") paper. Format all pages to display and print page numbers. Scanned documents should be scanned in Letter format, as black and white images only. Where possible, save scanned documents in .pdf format. 2. The required SF 424 Application for Federal Assistance and Assurances forms and any other required standard forms MUST be signed by your organization's authorized official. The Signature and Date fields on the standard forms downloaded from Grants.gov are pre-populated with the text "Completed by Grants.gov upon submission" or "Completed on submission to Grants.gov". Remove this text (manually or digitally) before signing the forms.

VI. Application Review Information

A. Criteria

To be considered for funding, applications must demonstrate a strong linkage to the most recent versions of JV conservation planning documents. Proposals for monitoring and applied research that improve JV conservation decision tools at larger scales (e.g., Bird Conservation Region) will be given higher priority. In addition, projects to address conservation priorities in State Wildlife Action Plans (<https://www.fishwildlife.org/afwa-informs/state-wildlife-action-plans>), and for JV focal species, should be highlighted. Proposals related to communications, education, outreach, and planning contributing toward JV goals will also be considered, if adequate funds are available. All submissions should explain how the outcome of proposed projects is regional in scope.

Grant applications will be reviewed and ranked by a 10-member Joint Venture Technical Committee. Applications will be evaluated on how well they support the Department of the Interior financial assistance priorities as detailed in Section I. Furthermore, the process will include individually scoring each application high, medium, or low for "Technical" (i.e., proposal is scientifically sound) and "Topic Value" (i.e., importance to achieving JV goals). After pooling these individual scores, Technical Committee members meet and review results of the collective ranking of proposals, plus they deliberate scoring variation (discrepancy among individual reviews). This discussion will result in a final proposal ranking by the Technical Committee, with recommendations for funding highest ranked projects provided to the Joint Venture Coordinator.

B. Review and Selection Process

Projects are reviewed by the JV Technical Committee and selected for funding by the JV based upon their recommendation. You are encouraged to discuss proposal ideas for the UMGLJV region with Science Coordinator Greg Soulliere (phone 517-351-4214).

Prior to participating in any review or evaluation process, all staff and peer reviewers, evaluators, panel members, and advisors must sign and return to the program office point of contact the "Department of the Interior Conflict of Interest Certification" form. For a copy of this form, contact the Service point of contact identified in the Agency Contacts section below.

Prior to award, the Service will review any applicant statement regarding potential overlap or duplication between the project to be funded and any other funded or proposed project in terms of activities, funding, or time commitment of key personnel. Depending on the circumstances, the Service may request modification to the application, other pending applications, or an active award, as needed to eliminate any duplication of effort, or the Service may choose not to fund the selected project.

The Service may not make a Federal award to an applicant that has not completed the SAM.gov registration. If an applicant selected for funding has not completed their SAM.gov registration by the time the Service is ready to make an award, the program may determine that the applicant is not qualified to receive an award. The program can use that determination as a basis for making an award to another applicant.

Prior to award, the Service will evaluate the risk posed by applicants as required in [2 CFR 200.205](#). Service programs document applicant risk evaluations using the Service's "[Financial Assistance Recipient Risk Assessment](#)" form. Prior to approving awards for Federal funding in excess of the simplified acquisition threshold (currently \$250,000), the Service is required to review and consider

any information about or from the applicant found in the [Federal Awardee Performance and Integrity Information System](#). The Service will consider this information when completing the risk review. The Service uses the results of the risk evaluation to establish monitoring plans, recipient reporting frequency requirements, and to determine if one or more of the specific award conditions in [2 CFR 200.207](#) should be applied the award.

VII. Federal Award Administration

A. Federal Award Notices

Following review, applicants may be requested to revise the project scope and/or budget before an award is made. Successful applicants will receive written notice in the form of a notice of award document. Notices of award are typically sent to recipients by e-mail. If e-mail notification is unsuccessful, the documents will be sent by courier mail (e.g., FedEx, DHL or UPS). Applicants whose projects are not selected for funding will receive written notice, most often by e-mail, within 30 days of the final review decision. Awards are based on the application submitted to and approved by the Service and are subject to the terms and conditions incorporated into the Notice of Award either by direct citation or by reference to the following: Federal regulations; program legislation or regulation; and special award terms and conditions. Recipient acceptance of a Federal award from the Service carries with it the responsibility to be aware of and comply with all terms and conditions applicable to the award. Recipients indicate their acceptance of the Federal award by starting work, drawing down funds, or accepting the award via electronic means.

B. Award Terms and Conditions

See the Service's ["Financial Assistance Award Terms and Conditions"](#) for the administrative and national policy requirements applicable to Service awards.

Any peer-reviewed publications produced under this award must include the following statement acknowledging support from the U.S. Fish and Wildlife Service: "This research was funded in part through a grant from the U.S. Fish and Wildlife Service, Division of Bird Habitat Conservation."

The Recipient will conduct scientific and scholarly activities as defined in Department of the Interior policy 305 DM 3, Integrity of Scientific and Scholarly Activities that are intended for use in Service decision-making processes and/or publications. Acceptance of this award carries with it the responsibility to be aware of and follow the Code of Scientific and Scholarly Conduct described in 305 DM 3, Section 3.7 to the best of your ability.

C. Payments

Domestic recipients are required to register in and receive payment through the U.S. Treasury's Automated Standard Application for Payments (ASAP), unless approved for a waiver by the Service program. Foreign recipients receiving funds to a final destination bank outside the U.S. are required to receive payment through the U.S. Treasury's International Treasury Services (ITS) System. Foreign recipients receiving funds to a final destination bank in the U.S. are required to enter and maintain current banking details in their SAM.gov entity profile and receive payment through the Automated Clearing House network by electronic funds transfer (EFT). The Service will include recipient-specific instructions on how to request payment, including identification of any additional information required and where to submit payment requests, as applicable, in all Notices of Award.

D. Reporting Requirements

The Service will include recipient-specific reporting requirements, including the required reports, reporting frequency, and report due dates in all Notices of Award, as applicable.

1. Financial Reports

All recipients must use the [SF-425, Federal Financial Report](#) form for financial reporting. At a minimum, all recipients must submit a **final** financial report. Recipients must notify the Service in writing if any employees, including subrecipient and contractor personnel, are related to, married to, or have a close personal relationship with any Federal employee in the Federal funding program or who otherwise may have been involved in the review and selection of the award. The term employee means any individual engaged in the performance of work pursuant to the Federal award. Failure to disclose and resolve conflicts of interest in a manner that satisfies the Service may result in any of the remedies described in [2 CFR 200.338 Remedies for Noncompliance](#), including termination of the award.

6. Other Mandatory Disclosures
